Characteristics of Hong Kong's Economy

- free trade
- Iow taxation
- 7th largest trading economy of merchandize
- 15th largest exporter of commercial services
- 3,955 regional headquarters and regional offices in Hong Kong representing their parent companies located outsides Hong Kong (as of June-2018)
- Among these companies, US accounted for 18%, Japan (17%), the mainland (11%) and UK (9%)



Hong Kong Food and Beverages Market


Hong Kong area 1,092 Km² with 7 million+ population

- <1% agriculture land, >95% of food supply relies on imports
- 58 million tourists in 2017, of which 44 million (~76%) were from China
- ~14,000+ restaurants (37% Chinese, 56% non-Chinese restaurants, 7% fast food outlets)
- 1,000+ bars, pubs and other eating and drinking establishments


Hong Kong's Trade on Food and Beverages







Hong Kong: Distribution Centre for Imported Food Destined for China/Asian Countries

- Foreign food imported into China is subject to customs duties (8-35%) and value-added tax (10-16%)
- Hong Kong is a free port and does not levy any customs duties on food imports
- Importers can first ship the products to Hong Kong then transship the right quantities to different cities in China according to the local demand
- Importers can also consolidate the products destined for China, Hong Kong and other Asian countries in FCL, then transship the other markets according to the sales level

Hong Kong's Positioning in Greater Bay Area

- On 1 July 2017, the NDRC, Guangdong, Hong Kong and Macau signed the Framework Agreement on Deepening Guangdong-Hong Kong-Macau Co-operation in the Development of the Bay Area.
- For Hong Kong, its primary aim is to consolidate and enhance its status as an *international financial, transportation and trade centre*, while strengthening its status as a global offshore renminbi business hub and an international asset management centre.

Transport Infrastructure Development Drives Logistics Service Upgrade

- Main transport routes on Pearl River estuary Hong Kong-Zhuhai-Macau Bridge (Oct 2018) Second Humen Bridge (~2019) Shenzhen-Zhongshan Bridge (~2024)
- With Hong Kong International Airport is to the east and Zhuhai (Hongwan customs clearance centre) to the west of the HZMB
- Shortage of warehousing facilities at HKIA, Zhuhai is tapping into logistics business (bonded process, bonded warehousing and repackaging)





Zhuhai Bonded Warehouse

Targeted cargo:

cross-border e-commerce goods; high-priced electronics/raw materials; chilled & frozen food (fruits/marine products/ cold meat)

- Zhuhai as a logistics distribution centre for the west of PRD-region
- HZMB will connect with: Beijing-Zhuhai Highway; Guangzhou-Zhuhai Expressway West Line; Jiangmen-Zhuhai Highway







Upgrade Cold Chain Logistics Services

- Rising demand for frozen food and fresh food from Mainland and ASEAN consumers
- Some Guangdong operators are partnering with Hong Kong/Macau logistics companies to enhance the import capacity of chill/frozen products
- Companies are eager to solicit advanced cold chain logistics solution in order to upgrade operation efficiency and quality
- Draw on the management experience of their Hong Kong partners and apply new information technology management systems to enhance the monitoring and inspection parts of cold chain transportation, and improve the processes of goods storage, transshipment etc.
